		Working capital; continue operations; support remote work. Up to \$10,000 per business. Loans to businesses up to \$25,000 per business; 3 to 5 year term, up to 2% interest, up to 1% loan administration fee with monthly, quarterly, or annual payments. Balance can convert to a grant if business retains jobs for at least 2 years. Payments can be deferred for first six months at 0% interest. Requires annual reporting by the community in perpetuity.

Borrowers in good standing may request short-term deferred, reduced or interest-only payments.</p>
